


SYARIAH COURT PRACTICE DIRECTIONS 2018 (AMENDMENT NO. 1 OF 2022)

The hakam shall endeavour to effect a reconciliation between the parties and only deal with issues relating to the marital status of the parties. If reconciliation cannot be effected, the hakam may effect a divorce, if they have been so authorised, including to pronounce talak on behalf of the husband if they so deem fit.


